

## **County Response Actions:**

- Continued to provide COVID-19 vaccines at the health department:
  - Wednesday, August 25<sup>th</sup> we provided 42 vaccines.
  - o Friday, August 27<sup>th</sup> we have 47 clients with appointments to receive vaccine.



- CG Public Health is preparing to provide COVID vaccine clinics at NIACC next week. These will take place on Monday, August 30<sup>th</sup>, and Thursday, September 2<sup>nd</sup>, 10:00 a.m. 2:00 p.m. each day.
- We continue to prepare to provide boost doses.
- Our Public Information Officer is working to put together a video for parents regarding guidance for children exposed to COVID-19 positive individuals.
- We continue to monitor our call volumes and will activate our call center if needed.
