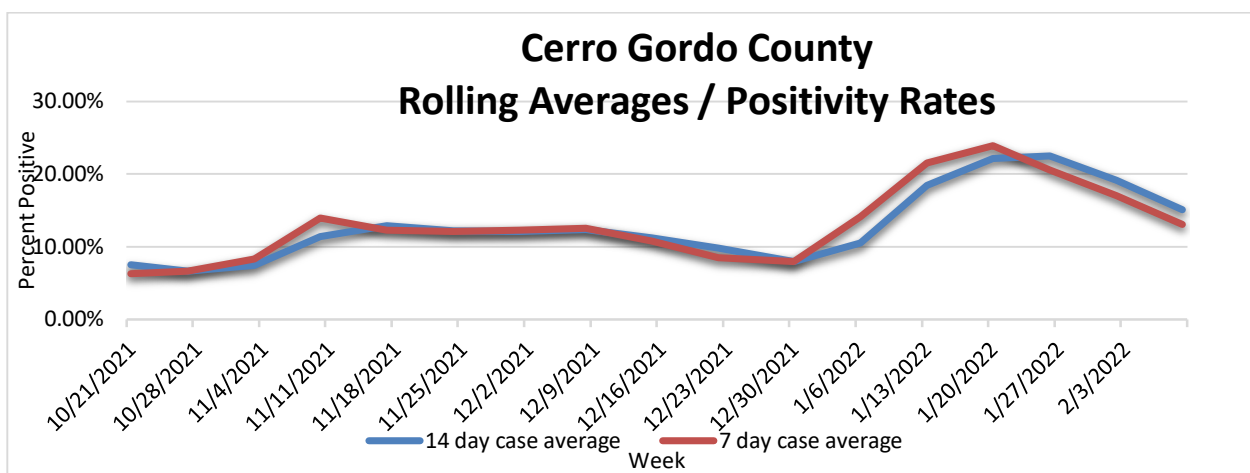

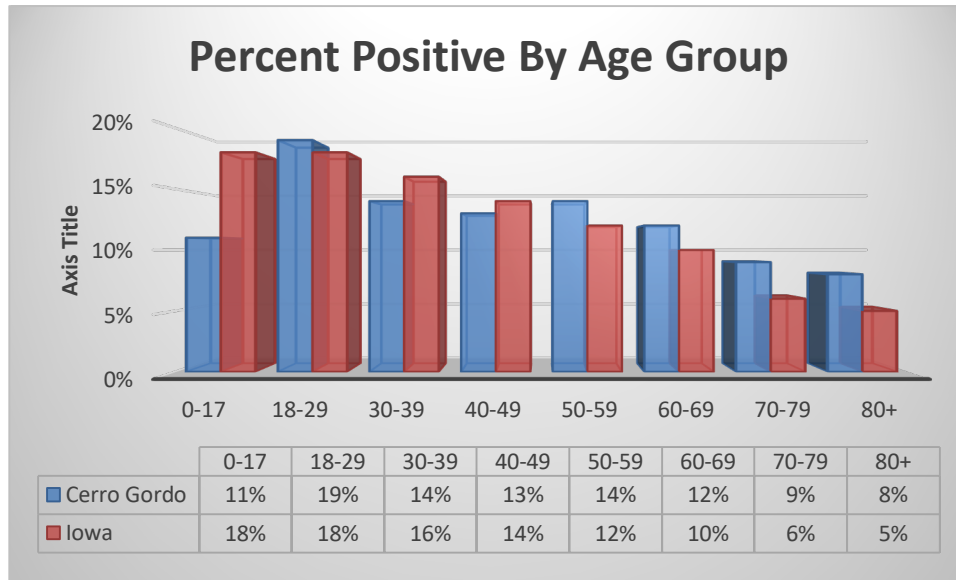

Governor Reynolds announced the state’s Public Health Disaster Emergency Proclamation will come to an end at 11:59 p.m. on February 15th, 2022. With this said, IDPH will be transitioning the way data is reported. Changes will include:

- Both the coronavirus.iowa.gov and vaccinate.iowa.gov websites will be decommissioned.
- Weekly reports that include COVID-19 data points will be published on the IDPH website beginning February 16, 2022.
 - Positive tests since March of 2020
 - Deaths since March of 2020
 - Cases by county
 - Positive tests in past 7 days
 - Epi curve since March of 2020
 - Variant breakdown by week
 - Vaccine data: total series completed, booster completed, county map, fully vaccinated
- IDPH is no longer requiring Long Term Care facilities to notify the department when they have three or more infections in residents.
- The vaccine finder tool will no longer be available.
