2020-21 Accomplishments By Andy Meyer, Board Chairperson

For more than 105 years, the Chamber of Commerce has played a vital role in the development of North Iowa. Through highs and lows, the organization has been a catalyst in bringing people together—much like a conductor coaxing beautiful music from a diverse array of instruments. The past year has demonstrated that we are definitely better together. Here are just a few of the high notes:

- Last October's **Annual Meeting**, held at the Cinema West Theatre to accommodate social distancing, was recognized by the Mid-American Chamber Executives as the Digital Campaign of the Year.
- Received national Chamber of the Year finalist accolades.
- The State of North lowa event included a video tribute to essential workers and all the ways local employers led our region through the worst days of the pandemic.
- The Chamber's leadership programs (*YIELD, College Connections*, and *Leadership North Iowa*) made the necessary adjustments and went on as planned. The *YIELD* students (with help from local business) refurbished Prairie Playground and the *LNI* class (with assistance from the City of Mason City) is working on the creation of a new community garden.
- Continued to promote and enhance talent attraction and retention through the **Community Concierge** program.
- Continued placemaking efforts as a workforce attraction and retention strategy through the Sculptures on Parade program, additional downtown murals, utility box wraps, and other beautification projects.
- Actively worked with Vision North Iowa partners to coordinate COVID-19 response locally.
- Despite the pandemic, produced a long list of events including *Chamber Bowl, Ag Breakfast, Golf Outing, Ag Tour,* and *Chamber Cup*, which provided great networking opportunities. The *North Iowa Band Festival* recognized Essential Workers with the Grand Marshal Award.
- Hosted elected officials including Congressman Randy Feenstra, Governor Kim Reynolds, Lt. Governor Adam Gregg, Iowa Ag Secretary Mike Naig, and Iowa Ag Deputy Secretary Julie Kenney for various events.
- Promoted diversity and inclusion through the **Breaking Glass Women's Leadership Series, CEO Conversations**, and "Make It OK" seminars.

MISSION

The mission of the Chamber of Commerce is to promote progressive community and economic development to benefit Chamber members and the North Iowa region.

SMALL BUSINESS OF THE YEAR

Aletalcraft, Onc.

A focus on PEOPLE and CONTINUOUS INNOVATION is the key to Metalcraft's success. The firm has a rich history in Mason City, dating back to 1933 as Kayenay Engraving & Color Plate. In 1948, following a strong R&D effort, the owners concluded that lithographic printing on metal was possible. What's more, the technique was superior to other printing methods, which led to the founding of Metalcraft.

Metalcraft specialized in the printing and serialization of nameplates—primarily for fixed asset application. In the early 1980s, Wally Smeby led a major product introduction at the company: metal bar codes. Bar code continues to be an important technology and is frequently used in conjunction with the company's next gen product offering: radio frequency identification (RFID).

In 2006, led by Doug Peterson and Steve Doerfler, the employees purchased the company from Wally Smeby, with Peterson serving as CEO and Doerfler as President. The new ownership team endured some challenges in 2008. First, historic flooding

caused severe damage to their building. Flood recovery was followed by the 'Great Recession.' Undeterred, they successfully weathered these events and determined a new facility was needed to accommodate their expansion plans. The company broke ground on the current facility on October 1, 2012 and on that same date, Steve Doerfler took over as President & CEO upon Doug Peterson's retirement.

Today, Metalcraft utilizes every square foot of space in the new building and has expanded the firm to include Ark Business Solutions in Mason City and Inlay Innovation in Ames.

For the past 8-9 years, the leadership team has adopted and embraced several core values: Member-Owners Focus, Customer-Centric Focus, Profitable Growth, Operational Excellence, Integrity, and Citizenship. They found by taking care of their people, they can count on them to focus on the rest of the values, which leads to the success of the company.

This Member-Owners Focus includes sharing of profits, which includes a short-term incentive, the ESOP, and generous contributions to the retirement plan. Metalcraft wellness programs include sessions with an on-site massage therapist; lunch-n-learns with topics centered on mind, body, and spirit; and incentives to reduce health insurance costs. They developed the University of Metalcraft leadership program to benefit each of their members.

Since Doerfler took the helm in 2012, Metalcraft has added approximately 50 positions with a total employee count of 130 members. The company recently celebrated its 70th anniversary, with a goal to continue building for the next 70 years.

On October 1, Kyle Bermel was promoted to President. Steve Doerfler will remain on the team as CEO.

DISTINGUISHED CITIZEN Mark Holt



Adventure-seeker and American Patriot Mark Holt is the well-deserved recipient of the 2021 Distinguished Citizen Award.

In 1998, Mark bought the feed-drying plant his father owned in Mason City and launched his own business, Varied Industries, to produce all-natural animal health products. An aviator at heart, Mark purchased a Phenom jet to visit his customers and transport employees to-and-from business meetings. When Mark sold his business to Church & Dwight, he found a new purpose for the Phenom.

Mark uses his personal aircraft as a volunteer for Veterans Airlift Command, and transports wounded and disabled veterans. In addition, Mark has used the jet to provide a flyover at Clear Lake's July 4th Parade.

But Mark doesn't need a jet to "fly under the radar." Few people realize all that Mark and his wife, Diane, do to make life in North Iowa better. Mark is the founder of the Community Emergency Response Team (CERT) for North Iowa. The Holts purchased a rescue boat for the Clear Lake Fire Department and are generous supporters of Newman Catholic Schools. They enthusiastically support River City Sculptures on Parade, and recently purchased a sculpture entitled "The Aviator" for placement at the Mason City Municipal Airport.

And Mark isn't afraid to get his hands dirty. In 2019, he assisted with the restoration of the Historic Egloff House by using his own heavy equipment (which he affectionately refers to as his Tonka trucks) to excavate, level, and dump loads of black dirt on the property so grass seed could be planted.

All this, and So. Much. More.

The Distinguished Citizen is selected each year by a panel of former award recipients who consider leadership, membership and participation in community organizations, and active service to the community.

Prairie Playground Preservation

The 2020-21 **YIELD** class came up with the idea to restore Mason City's beloved Prairie Playground, located in East Park. Passionate about restoring a place where they grew up playing, they wanted it to be available for future generations to enjoy.

The **YIELD** group met with city staff to address concerns and completed a safety report card from the National Program for Playground Safety to address the condition of the playground. Thanks to generous contributions from businesses and community members, new equipment, including an accessible swing and a sand digger were installed and numerous other repairs and replacements were made to broken equipment.

YIELD students were assisted by several Chamber members to replace the old mulch with engineered wood mulch – an ADA approved fall surface – making play safer for children. Finally, students spent multiple days applying a fresh coat of stain to the entire structure.

CHAMBER FOUNDATION

The Chamber Foundation, a non-profit corporation classified by the Internal Revenue Service as 501c3, supports the long-term work of the Chamber of Commerce in its community and economic development efforts to benefit Chamber members and the North Iowa region.

The foundation applies for grant funding for specific community development projects such as the Historic Egloff House, the *Vision North lowa* strategic planning process, the "Building Our Brand" mural project, and most recently, the "That's A Wrap" project to beautify utility boxes in Mason City's downtown.
