# **2022-23 Accomplishments**

#### By Evan Raulie, Board Chairperson

2022-2023 has been a year of change and growth for the Chamber of Commerce. We started the year with our first leadership transition in decades. Colleen Frein was promoted to President & CEO, succeeding Robin Anderson in the position Robin had held for 22 years. By all accounts, the transition has been successful. Colleen has focused her first year on operational improvements, mission alignment, and organizational transparency, and the result has been positive change for our member businesses. Here are just a few of the big items we have accomplished this year.

#### **Advocacy & Civics**

2023 saw a renewed emphasis on bringing members into our advocacy efforts. The **State of North Iowa** shed light on some of the major projects and initiatives happening in our region. About a dozen people participated in our North Iowa Day at the Capitol, where we met with our state representatives and department leaders to advocate for our region and learn about their priorities. The 2nd Annual **North Iowa Civics Bee** saw 20 participants in the live bee, and the top three students competed in the first Iowa Civics Bee. We also hosted several elected officials over the past year, including Representative Ashley Hinson and Lt. Governor Adam Gregg.

#### **Real Solutions for Workforce Attraction & Retention**

This year, we turned our attention to four key areas: **Community Concierge**, **Building CommUNITY**, Child Care Access & Affordability, and developing our leadership pipeline.

We built on the successful **Community Concierge** program by training all staff on providing community tours – allowing us to match the tour guide with the interests of the candidate. The **North Iowa Navigators** program takes this tailored approach to the next level by providing a new or prospective resident with a local "expert" in life in North Iowa.

In order to grow our population, we need to embrace diversity. The **Building CommUNITY** program focuses on ways to make our businesses and ourselves more inclusive. Nine worksessions were held this year, with 36 businesses participating and nearly 200 people in attendance throughout the sessions. We are also engaging with our fastest-growing population – Micronesian families. In partnership with others, we are working to overcome language barriers and incorporate their culture into North Iowa.

Child care access & affordability is not a new issue, but it has reached a crisis point. This year, the Chamber partnered with others to find short-term and long-term solutions. We raised nearly \$500,000 between business investment and matching funds to launch a Child Care Works Wage Supplement Program, slated to launch in January 2024.

In order to grow our workforce, we need to focus on emerging leaders. This year, the Chamber partnered with Mason City Community Schools to grow their STEM offerings for K-12 students and create a Senior Work Program to help graduating students launch their careers. We also added to our award-winning leadership programming, hosting a Leadership Seminar in the spring and the largest **Breaking Glass** event to-date.

#### **Community Leadership & Engagement**

We continued in our legacy of moving the needle on community initiatives. After the Kirk Apartments were destroyed by a fire, the Chamber led efforts to salvage historic pieces of the building that can be repurposed in a future structure on the site. Monthly community partner meetings started this summer, and ensure everyone is rowing in the same direction. The **North Iowa Band Festival** saw its highest attendance in decades, and a new Spirit of Meredith Willson Award aims to increase the number of high school marching bands participating in the "Big Parade."

Your Chamber staff are tremendously talented, and they are committed to the organization's mission and serving you, our members. It has been my honor to lead the Chamber of Commerce in these efforts and many more over the past year. Thank you for the opportunity.



#### **PROJECT: Sled Shed**

# **Community Concierge**



The **Community Concierge** program is just one way the Chamber is working to address workforce issues in North Iowa. This high-touch service provides individualized assistance for attracting and retaining new employees by offering a personalized community tour for the job candidate and their family, cost-of-living comparisons, and relocation assistance once the employee signs.

Chamber members recruiting for a position in their company may use the Chamber's **Community Concierge** service and pay per referral at a fee of \$250. Sponsorships are also available for businesses who hire multiple positions yearround, which include additional benefits and numerous referrals.

The Chamber is looking to expand its efforts and utilize community members to help make North Iowa a more welcoming place with the addition of the **North Iowa Navigators** program. The purpose of the **Navigators** is to connect candidates or new residents with a community member who has chosen to live here and who can help a newcomer feel welcomed and connected. The **Navigators** will offer knowledge of the region in terms of lifestyle, recreation, schools, healthcare, real estate, industry, and career opportunities. **Navigators** will be vetted, selected, and trained-in by Chamber of Commerce staff who will ensure diverse backgrounds and knowledge, industries represented, and a welcoming and friendly attitude.

#### **PROJECT: Addressing Food Insecurity**

The 2023 Leadership North Iowa students selected a community impact project focused on food insecurity in North Iowa. The group was approached by a new non-profit organization, North Iowa Mutual Aid, to assist with a community fridge program.

The students met for weeks discussing how a community fridge would work, collecting input from area partners, researching best practices, and fundraising. The class was able to secure a location for the community fridge at Prairie Ridge's downtown location. Funds raised were used to purchase a new refrigerator for the site, as well as support two well-known local organizations who work in reducing food insecurity -Community Kitchen of North Iowa and Hawkeye Harvest Food Bank.


